Annual Report of activities for 2013

The "European Forum for Studies of Policies for Research and Innovation", Eu-SPRI Forum, aims to strengthen the vibrant but dispersed interdisciplinary community of researchers focusing on interdisciplinary dimensions related to policy and governance in the field of knowledge creation and innovation. Studies of Policies for Research and Innovation, SPRI is a growing research field since the 1960s, evolving at the encounter of economics, political science, sociology, Science and Technology Studies, STS, business administration, geography and history. The Eu-SPRI Forum was founded in Paris in June 2010 and has presently sixteen full members and one associate member.

Annex 2

Short report on the Early Career Research Training School: "Measuring and modeling dynamics in innovation systems": Utrecht University – 26-30 August

Key figures:

- Number of participants: 32
- Number of staff members from Utrecht University involved: 13 (7 lecturers and 6 more as presentation discussants)
- Number of external speakers: 2 (Loet Leydensdorff, UvA and Edwin Horlings, Rathenau)
- Average course evaluation grade: 8.44

In the last week of August of 2013, the early career research school "Measuring and modeling dynamics in innovation systems" was held at Utrecht University. The school received 41 applicants, we were able to place 32 students from all over the world. Most were relatively new to the field of innovation studies, but the background varied greatly. The course was also part of the Utrecht Summer School program, which is the largest summer school of the Netherlands. The main advantages of this choice was that the registration and organization process was managed by a professional experienced organization and that the course was internationally advertised.

During the week participants were introduced to various theories and methods that are (or could be) used in innovation systems research.

- On Monday the students were familiarized with basic about innovation systems.
 Second, there was a discussion session about theory and stages of theory development. Later, students were introduced to event-history analysis as tool to analyze dynamics of innovation systems.
- On Tuesday students received a lecture about knowledge development and a guest lecture about evolutionary perspectives on the triple helix by Loet Leydensdorff. Later, students received training in how to use social network analysis as a tool to study knowledge development by Gaston Heimeriks and Edwin Horlings.
- On Wednesday students were first lectured on how the demand side of innovation is both a selector and variety creator (user-producer interaction) for innovation. Second, there was a lecture about how to measure preferences in a quantitative manner, which as followed by a workshop about choice experiments.
- On Thursday students received a lecture that introduced some theories about firm behavior that are compatible with the innovation systems idea: institutional theory and organizational ecology. Second, theories about open innovation and innovation strategies by firms were elaborated upon. The day continued with the playing of a serious game called "solar tycoon" (www.solartycoon.nl), which is an innovation-entrepreneurship simulation developed by staff members of the innovation studies group. In this game students had to apply the strategies they learned in the simulation.
- On Friday, students followed a workshop about technology dynamics, mainly the
 diffusion model by Bass (1969) and the idea of lock-in. Finally, the day contained a
 discussion session about how all the elements of the previous week could be integrated.

Every day there were parallel sessions during which students could **present their own research**. Two staff members of the Innovation Studies group familiar with the presentation topic were present during each parallel session to give comments and help to improve the research. All students presented their work.

Finally, there were many social activities that contributed to the great atmosphere and helped people to really know each other:

- On Monday there was first a "get-to-know-each-other-lunch". In the evening there was a barbeque. After that there was night-canoeing, students could canoe from the campus to the city center over the famous canals.
- On Tuesday there were opening drinks at the Academy Building of Utrecht University and a small meal. Before that students engaged in "Floortje's Fun Activity", a small quest through Utrecht past historic sites.
- On Wednesday there was coffee and cake at the Copernicus Institute. In the evening students could choose to have a free meal at the university restaurant. However, most students opted for having a diner in the much nicer city center.
- On Thursday there was a **farewell dinner** in the city center, after which most students decided to go out dancing.
- On Friday at five o'clock, there were **some left-over drinks** for the students that were interested. Almost all students were.

The full program is given as appendix. There were also some points for improvement:

- In the future we will take more time for the student exercises. We will look critically at the program for this.
- The lecture room turned out to be a bit small for practical exercises. Later it was upgraded.
- Students received a lunch box every day, to allow them to have lunch outside. However, this produced too much garbage.
- The Eu-Spri forum has a rule that student accommodation should be around 50 euro per night, with students having their own room. This turned out to be impossible in Utrecht at this time of the year. We had to house students between 85 and 90 euros (breakfast included). The difference in housing costs is paid by the Utrecht University contribution. Students were very satisfied with the accommodation.

Overall, the organizing committee believes that the week was really successful and the weather was great. This impression is confirmed by the student evaluation who graded the course with an 8.44. Students really appreciated the course and were surprised that this was the first time it was given. Also all staff member were really enthusiastic about the group and how much fun it was to teach for PhD's. Given the success of the course, the Innovation Studies group is seriously considering to continue this initiative next year around the same time.

Finally, we are extremely grateful for the contrbituion of EU-SPRI, which made this event possible!

Final Report of the Eu-SPRI Early Career Conference Science dynamics and research systems; the role of research in meeting societal challenges in Madrid – CSIS Centre for Social and Human Sciences (CCHS) on 8-9 April 2013.

1. Objectives:

The ECRC was defined as side event to the General conference, with a broader theme related to science policy studies and with the objective of providing the opportunity to complement the managerial and innovation approach defined in the general Conference.

The basic objective of the ECRC was to open the space for interaction and involvement of world-wide presenters and seniors from Eu-SPRI and also non-EUR-SPRI institutions and from disciplines and fields that at origins of S&T policy studies were well connected (e.g. bibliometrics, history, philosophy of science, etc.). The target was broadening our activities and increasing impact in the field.

To implement the objectives we decided: A) to have up to 50% of non-EU-SPRI participants. B) To invite academics from non-European institutions and from a couple of potential candidates to joint EU-SPRI. C) To fix a maximum of 10% of papers from our institution for the final program, considering that our PhD students and postdocs could attend without cost.

The call for papers was made in quite general terms to allow the participants to self select the proposal content, mainly based on the signals that the Scientific Committee playing the role of discussants could represent.

The message sent to the participants, in the call for papers, was the need to have a full paper (even in draft version) at the required deadline to be included in the final programme.

4. Papers at the final ECRC Programme:

The **final program was arranged with 24 papers**, from 13 different countries (and 21 different institutes). All papers were presented.

From the 29 pre-accepted abstract, 5 papers were not delivered at the deadline, then they were removed from the draft program.

The final distribution by Institutions: 13 papers from EU-SPRI institutions and 11 papers from non EU-SPRI institutions were included in the 4 sets of 2 parallel sessions (of 3 papers each).

The total number of participants in the ECR Conference, including people from the CSIC-IPP, during the 2 days was around 50.

5. Format of the Conference

As the conference was planned for two days, we organized two tracks, with a total of 8 parallel sessions to fit 24 papers, each of 2 hours.

Each session had a chairperson to keep the timing. Each **speaker had 20 minutes** for their presentation. Each paper in the conference was discussed by one senior speaker. Discussants were sent the papers in advance and asked to prepare **between 5-10 minutes of comments**, **criticisms and suggestions for improving the papers**. The rest of the time, up to 40 minutes, was for guestions and comments from other participants.

Coffee breaks of 30 minutes (just outside the meeting rooms) increased networking and gave time for more in-depth discussions between junior researchers and with senior mentors.

In the plenary sessions senior people volunteered to make lectures (6) and bring personal experiences as research [Jochen Gläser (2), Ben Martin (2), Barry Bozeman (1), Arie Rip (1) and Carl Mitchan (1)]

6. Awards and prices for Best paper

The 9 senior academics got, 2 weeks in advance, all papers presented and were requested to identify the best paper and finalist paper. A brief meeting was held on Tuesday 9, taking some of the lunch break.

Based on the idea of the need to differentiate between post docs already with some time elapsed after the PhD and predoc or people just good PhD students, a consensus emerged to provide 2 best paper awards, one for pre-doc and another for postdocs.

The results were:

Post-doc best paper: "Vaccine innovation, research translation and knowledge management: Testing processes in three polio trajectories" by Ohid Yaqub, SPRU-Science and Technology Policy Research, University of Sussex (UK).

Pre-doc best paper: "Personal publication productivity: scientists, their friends and other collaborators" by Agrita Kiopa, School of Public Policy, Georgia Institute of Technology (US).

8. Diffusion Issues

A specific section in the <u>www.ipp.csic.es</u> page was established to provide regular information to participants,

However, most of the contact was personal, by email though an account specifically created (Contact email for the conference was: ecrc.ipp.madrid2013@cchs.csic.es)

Twitter was used for dissemination and direct impact. A hashtag #ecrc2013 was used for this purpose. More than 400 followers were aware on time and direct communication.

9. Opportunities of the EU-SPRI Forum Annual conference and EU-SPRI ECRC side by side

We believe the model, side by side conferences, is good and should be taken on board to the next Conference. It creates synergies and, potentially division of labour; and the senior people were ready to stay a couple of more days.

However some lessons should be extracted, for other conferences in the future, to avoid some confusion created by simultaneous dissemination of CFP for both events.

10. Other lessons that could be useful for other ECRC

Limiting the number of presenters (and seniors) from the local organizing institution is a good thing and we recommend a regulation from the EXC, that could contribute to a broader exchanges and mobility of people from EU-SPRI members. In our case we agreed not to accept more that 10 %, but it is just a reference.

The necessary requirement of having the full paper a few weeks in advance to be in the program is a necessary way of doing things more seriously. A few persons were excluded of the program for not sending the paper on time.

Without planning a clear distinction it come out that the quality of papers could be partially associated to the maturity of the candidates. **Having explicitly a combination of more predoc (in late phases) and post docs (in early career) is a very positive element**, but independent recognitions and awards should be arranged (as we did in a muddling through mode).

A practical problem in this type of conferences, especially once required the full paper, is the fact that sometimes **the paper is co-authored by a senior people**. The CFP should make the point clear from the beginning that if it is joint work, only the name of the junior presented will be in the program and the assessment will be made considering that it is joint work.

Involving senior people from other EU-SPRI institutions and non-EU-SPRI, and breaking the closed shops and always having the same people around, is a very positive element.

A final warning: It could be a random outcome, but from the 4 winner of the best papers and finalist none was from an EU-SPRI institution. We should monitor the quality of the products our PhD students and post doc deliver.

37 early career researchers (36 presentations) participated in the conference. 19 were from the Eu-SPRI Forum organizations and the rest come from non-member organizations. The following Eu-SPRI forum member organizations were represented: Copenhagen Business School, Manchester Institute of Innovation Research, Universidad Autonoma de Madrid, INGENIO, Fraunhofer ISI, CIRCLE. Non-members come from University of Oslo, University of Turku, Norwegian Business School, Radboud University Nijmegen, University of Bern, Salzburg University, Umeå University, University of Gothenburg and others. Next to early career researchers, 7 senior researchers participated as keynote speakers: Prof. Meric Gertler (University of Toronto), Prof. Markku Sotarauta (University of Tampere), Prof. Marko Hekkert (Utrecht University), Prof. Susana Borrás (Copenhagen Business School and Lund University), Prof. Cristina Chaminade (Lund University), Dr. Elvira Uyarra (University of Manchester), Dr. Michaela Trippl (Lund University). (Prof. Keld Laursen could not come to the conference due to personal reasons.)

Format

The conference was organized as two days event consisting of plenary and parallel sessions. Plenary sessions were held by senior researchers (see above). The time slot for one plenary speech was one hour (45 min presentation + 15 min questions/discussion). Senior researchers were chairing the sessions. Early career researchers were active in raising questions. Thus, the time was used to its fullest. Presentations and/or papers of the keynote speakers are available on conference website:

http://www.circle.lu.se/events/eu-spri-early-career-researcher-conference/?page_id=5 Parallel sessions consisted of three presentations. Each presenter was allocated 30 min (15 min presentation + 5 min junior discussant + 5 min senior discussant + 5 min answers/open discussant). Discussants received the papers a few weeks before the conference and were instructed to prepare 5 min comments. The parallel sessions were chaired by early career participants. The format was highly appreciated by the early career researchers. They found comments from two discussants beneficial for future development of their research ideas. At the end of the second day Prof. Susana Borrás summarized the conference telling more about Eu-SPRI forum, possibilities within it as well as provided an overview of the topics addressed in the conference.

In addition to the sessions, the researchers interacted during coffee breaks, lunches and conference dinner. Some of the senior researchers were present in all of the events. Overall, the conference was a success. It was appreciated by senior and junior researchers. They pointed out that it was inspiring topic wise, useful for future research because of the prepared discussants and smooth due to well organized practicalities.

Final Report of Annual Conference 2013

The Management of Innovation Policies: new forms of collaboration in policy design, implementation and evaluation, Madrid, 10-12 April 2013

The third edition of the Eu-SPRI Forum Annual Conference took place at the Hotel Meliá Castilla, Madrid, between 10 and 12 April. The Conference topic ("The Management of Innovation Policies: new forms of collaboration in policy design, implementation and evaluation") and the organization and focus of its plenary sessions intended to provide a problem-oriented, applied approach to the proceedings. There was a total of five plenaries: three roundtables and two keynote speakers. Each roundtable had a chair and three participants: an academic, a specialist providing a view on the topic from a public sector perspective, and an expert from the private sector. The keynote speakers (Prof. Ben Martin, and Prof. Barry Bozeman) addresses focused on topics with applied policy implications.

Academic papers were presented in parallel sessions. We limited the number of simultaneous parallel sessions to four, and we held a total of 20 parallel sessions (including six sessions from three "special tracks") and one "special lunch break seminar" sessions. In total 100 papers were presented in these sessions. In addition there was a poster session for Early Career researchers (14 posters were eventually presented) and an "Open Forum" for papers that were considered to be at an earlier stage of preparation (15 papers presented). In total, 165 proposals were submitted (papers, extended abstracts and poster proposals), out of which 103 were initially as oral presentations in parallel sessions, 24 were accepted for the Open Forum, and 15 as posters. Many of these contributions were co-authored, involving 305 authors from 30 different countries:

The Conference received a total of 186 registrations, out of which 79 were from Spanish participants, 87 from other European countries and 20 from the rest of the world.

The "Open Forum" sessions were a new format in the EuSPRI Forum annual conferences. The Open Forum is a common practice in some management conferences, but their implementation varies across events. In principle it allows papers that are at early stages of development to be presented and discussed in the Conference, providing some authors with the necessary requirements (inclusion in the Conference programme) to obtain funding to attend the Conference and, in our case, releasing some of the pressure on the programme. We had initially planned the "open session" in a completely unstructured way: just tables in an open space were the authors of each paper could discuss their papers with any individual who would approach them. Although the format was explained to the authors in the acceptance letter, on the day there was uncertainty about how the session would develop. We decided at the last minute to change the format, and to turn into an open discussion among the paper authors and other attendants. The discussion was preceded by very short introductions by the authors and informally chaired by INGENIO researchers who happened to be among the paper authors in both sessions. The feedback we got from these sessions was positive.

We feel that the open forum provides and adequate format to increase conference participation among authors whose papers may not yet be ready for oral presentation. Yet, the initial format we had selected (basically authors waiting for "visitors" to "their" tables) would have probably failed in a context like ours where this format is not known. The avenue taken, an open, but "chaired", discussion format, among authors of early work-in-progress papers can potentially be interesting, but would require careful planning (both in the selection of papers and for the role of the Chair).

Rules for supporting Eu-SPRI events and activities

1. Type of support

Eu-SPRI Forum offers support, only in the form of grants, for the organisation of events (Early Career Researcher Conferences/ECRC; PhD summer/winter schools; Eu-SPRI bi-annual Conferences; Exploratory Initiatives).

The grant is a lump sum earmarked for the effective completion of this activity.

The grant is fixed on the basis on an initial budget (see below).

Payment is made once the activity has taken place and is documented on the website of the Forum (http://www.euspri-forum.eu/; e.g. for conferences the programme, presentations made, results from panels and discussions, a synthesis of the main achievements of the event, for summer/winter schools the presentations of lecturers and summary of plenary events, for exploratory activities documentation of the activity and the actual output paper).

A final financial statement of the activity supported will have to be produced within 3 months of the payment.

2. Establishing a budget

We underline below 3 important principles that member organisations asking for support need to take into consideration.

- a) The grant aims to cover basic costs incurred by the host. As budgets are limited, we encourage organisers to organise the events wherever opportunities exist to obtain cheaper accommodation. We wish to keep this approach in order to maximise the number of events supported.
- In the case of ECRC and PhD Schools Eu-SPRI will cover accommodation and food including conference events. Participants should be accommodated at a cost of around €50 euros per night per person. This is important since we intend to provide support for as many as possible participants as possible.
- b) This principle applies only for early career researchers from member institutions. While we wish to keep these events open to all, there is a need to differentiate between Eu-SPRI members and non-members. The principle adopted is that non-members will not receive any financial support from the Eu-SPRI Forum. Non-member will have to cover all costs generated by their participation (including all meals); as an example this amounts to €300 per participant for the 2011 Doctoral conference in Manchester. The proposal may include a small number of bursaries for targeted audiences (e.g. early career researchers from non-OECD countries or from European new member states).
- c) The Forum is a joint investment by our institutions to provide a European-level framework for our field. They in turn expect that we, as academics, invest our time and effort in making it productive. It would be difficult for them to accept that the colleagues we invite do not share the same objectives. These points have two very practical financial consequences: in organising operations, account should be taken only of managerial costs incurred (not academic working time dedicated to the scientific aspects of the organisation of the event); EU-SPRI Forum cannot pay honoraria for invited speakers and these should not be included in the budgets. Only travel and subsistence expenses should be considered as eligible costs, for selected Early Career researchers and participants of Exploratory Initiatives of EU-SPRI members, and for invited speakers.

As an example that applicant should feel free to follow, we attach the budget that has been submitted for the 2011 Early Career researcher Conference in Manchester.

3. Types of Resources

In addition to the Eu-SPRI grants, we expect that events will be able to use three types of resources:

- * Fees from participants (these for instance amounted for the 2010 Eu-SPRI-IGS conference to some 14.000 Euros).
- * In kind contributions made by the organisers (rooms, student time...)
- * Other external resources.

The consideration of all expected resources is central for deciding the amount of the grant to be offered. The ExCo trusts colleagues for the fact that these estimates are well prepared so that the Forum as a whole does the best use of its limited resources.
